Identifying our passions

Too often in today's social and political climate - through social media and 24/7 News Commentary - we are exposed to an overwhelming display of anxiety, intolerance and offense; and all of this is experienced instantaneously and on a global scale. Sadly, many times we witness, exchange or take part in these passionate expressions, and in spite of our ability to reason through logic for or against a topic, we are left feeling exhausted and frustrated. Sometimes this is because much of society has been programed to think a certain way rather than being taught the ability to think critically for themselves, but other times it's our passions that get in the way, but mostly we may find that it is combination of both.

With our technology in its adolescent stages of growth, along with our pop culture's instant gratification mentality, we find it all too easy, and often times obligatory, to express our opinions while our blood is hot. This is often done with no regard around how our opinions may be interpreted, and with no self-evaluation of our own intentions, nor any understanding of someone else's intentions. And when it comes to a presentation or a debate, it is far too easy for one to just berate an idea or a process – which may have been presented in order to correct a wrong or to start a progress towards a correction – rather than provide an amendment to the proposal in order to seek out a joint solution to the problem being discussed. This is because

many live predominantly in an "us & them" mentality, and they do not realize that this type of mentality does not allow the concept of Peace, Harmony & Balance, but demands anxiety, strife and chaos; therefore, due to their bias, an amendment may never be considered by either of the debating sides.

Many groups/organizations that have sprung up from this climate have been primarily designed to demonize, marginalize or isolate a certain group of people. Their goal is to unite one particular group against another - inspiring and encouraging an "us & them" climate. These groups/organizations are not created in the spirit of unity, truth or love, but distort the three in order to propagate their own agenda and to antagonize. Convinced of their narrow minded and one sided solutions – which are drawn from their diminished faith in their own capabilities and their diminished faith in humanity – they hate in the name of self-love; and because they are faithless, intolerant and united in their unbridled passions, they blindly muscle their way through the ranks and dictate their rule by their emboldened passions and intoxicating ignorance. These organized groups along with many individuals in our society, have allowed their passions to rule; and in doing so, will soon find themselves "falling headlong among the sharp rocks by the impetus of their own blows," but the fall can be slow going and is not always immediately realized. While the fall is in motion, heated contention and then bitterness along with hard feelings will be prevalent in all their communications.

Passion is a force, and the result of unregulated or ill regulated passion is anger, self-gratification and fear... the fear of losing or of being cheated out of something one feels they deserve. We as Freemasons are not immune to what is common to the human condition; and if we are not careful, we may also become blinded or swayed by our passions – even against another Brother – just as quickly as any other unbridled passionate soul that lacks strength and establishment.

As Freemasons we are required to look to Truth & Love, which work together as the "two great motors"

that power the "force of thought" and "energy of philosophy"; which thought and philosophy are required to flow through the "brain" of the "Force" to write and enforce its "law" in order that we may circumscribe our desires and keep our passions within due bounds; only then are we able to act and communicate in a manner that unites rather than divides. Harmony, Peace, Chaos and Strife can all be reciprocated; but it is the individual's choice as to what they will reciprocate.

"When all these Forces are combined, and guided by the Intellect, and regulated by the Rule of Right, and Justice, and of combined and systematic movement and effort, the great revolution prepared for by the ages will begin to march. The power of the Deity Himself is in equilibrium with His Wisdom. Hence the only results are Harmony." Albert Pike – Morals & Dogma

Grammar, Rhetoric & Logic

"Do not expect easily to convince men of the truth, or to lead them to think aright." Albert Pike – Morals & Dogma

Freemasonry never requires its members to force Truth or Light on to others; this is what our Charges teach, and this is why we do not recruit. But what Freemasonry does require of its members, is to strive for and to understand the importance of a strong, stable and true foundation by which we may build our own Temple. We are taught the importance of circumscribing our desires and controlling our passions so that we are able to harness the strength that is found within them. Freemasonry teaches us to establish our Temple by recognizing the need for Harmony (3), respecting and valuing different cultures (5), and gaining knowledge through the study of Arts & Sciences (7); therefore, it is incumbent of us to improve how we view and understand our world and surroundings, and how we should act, interpret and respond to it.

Our world and surroundings are common to all mankind, including the "us & them" crowd. Therefore it becomes part of our development to understand the position and passions of not only ourselves, but the position and passions of "the opposition" as well; not for the sake of the opposition alone, but for the sake of understanding. So, having a clear understanding of our own agenda or values alone, along with the reasoning skills

to communicate them, is not enough to realize Peace & Harmony. It is important to remember that the world is not and has never been in lack of martyrs, even though some of those martyrs were in Harmony with this world & the Deity, and there were also some that were not — both the lion and the dog are subject to the same end. So, we would be foolish to think that we have the ability to bring Peace & Harmony to anyone — some do not want it, and some are not ready for it. But this is not our obligation, our obligation is to realize Peace and Harmony within ourselves; and the only way this can be realized is to continually gain understanding of "the opposition" that we are faced with both internally and externally — because everything is common in the human condition.

We should never forget that everyone feels the need to be understood, respected and valued, and we as Freemasons should strive to become capable of providing this to others without diminishing our own position; we may even gain correction or gain more clarity of our own position in doing so – but this can only be achieved if we are proficient in all of our Degrees.

When we approach the opposition with the understanding that there may be just as much logic, reasoning and passion that has gone into their position as we have invested in our own (sometimes there is more passion than reason or logic, but there are always elements of all three present) and that only Truth & Love can provide the clarity needed to see beyond imbalances or blind passions, only then can we find the common ground needed to bridge the gap.

As AASR Freemasons, we are required to never lose faith in the strength of our foundation and the establishment of our truths to provide us the ability to communicate respectfully in a way that exercises Peace & Harmony; and to never lose faith in our fellow man's potential and ability to do the same.

Several other members of the craft and I are working together as a team and we are moving forward in our efforts to RECOVER, REBUILD, AND TO REJOICE. I call these the Three 'R's. We are going to RECOVER from the flood, we are going to REBUILD from the flood, and we are going to REJOICE in God's Love with all the help, aid, and assistance given to us from lodges all over the country. This is what makes us Masons, and this is why we call ourselves Brothers. The Honor is to Serve.

Venerable Master's Message

Returning from the July Grand Lodge session, as I was driving home, I considered the strife that has been upon the Valley since the flood. We lost our home, and without insurance coverage, it felt like we lost our future. It took more than a third of our funds, just to clean and remediate the buildings to eliminate any health hazards. The estimates to repair just the annex would have consumed the remainder of our funds, and as the valley was already losing money annually, this would have brought insolvency to the valley. We still have our recurring expenses, utilities and fees to satisfy, but in order to keep the valley with a future the members voted to not use our current funds to repair the buildings. While this was a hard decision, it has forced us to use the benevolence of others and our own members to do the repair work on the Annex. I am happy that we will be returning to the Annex in August and I am proud of the many members who have contributed time, money and physical effort. Many of these people suffered personal losses as well. Their efforts have given the Valley a future, and we will forever owe them a debt of gratitude.

This reminds me of the five brothers who kept Humble Cottage Lodge meeting during the War of Northern Aggression. Being too old to serve in the army, they took it as a duty to keep the lodge meeting, not for themselves, but for the brothers who could not be there to have a viable lodge to return to.

So as we return to the Florida Boulevard location, we now have a future. Not a guarantee, but a chance. For this opportunity to continue, it will be necessary for more of the members to return to the valley meetings. The floods have decreased our number of dues paying members to a critical level. The only way to overcome this is to grow the membership, this can be continued page 10


