The Knights of St. Andrew

Our Mission

The Knights of St. Andrew is made of an elite unit select Scottish Rite Masons.

The Knights of St. Andrew exist as a service organization on behalf of all members of their Consistory. They are under the immediate supervision of the Secretary of their Scottish Rite Consistory and provide services where they are needed. This includes, but not limited to, aiding the Tylers, acting as greeters, providing escort services for dignitaries or for special events created for the ladies during reunions or other functions, serving as guides, assisting the Scottish degree work, helping present the Colors. Knights of St. Andrew also assist in the calling committees, participate in parades or civic activities, promote fund-raising events, and aid in any special event. The list can continue on as new ideas and concepts are developed to meet needs and goals.

Their flexibility and enthusiasm make the Knights of St. Andrew one of the Valley's most active and desirable organizations. It is an excellent way to nurture and develop future leaders as they learn their organizational and leadership skills, explore the inner structures of their Scottish Rite Centers, and thus gain a deeper admiration for our Order and Brethren who work in Freemasonry as a whole.

Membership and Identity

The Knights of St. Andrew replaces the Shrine for generating membership for the Scottish Rite. Membership is limited to 32nd degree Freemasons and will abide by the Valley's by-laws, and those approved by the Sovereign Grand Inspector General of each State.

The Knights of St. Andrew are identified by their flamboyant uniform and regalia; often entering special events accompanied by bagpipes and drums, becoming the elite unit of all Scottish Rite Masons. This is the best means of attracting younger members (ages 35 through 55 yrs.). It has all the magic and color used by the Shrine following WWII in the early 50's, before a tired and aging membership put it to rest.

A Way for Acquiring Quality Membership

Each of the Forty charter members is given a "Squire's Coin". During the year each Knight will select a Master Mason or non-Mason who he considers to be worthy of joining this Elite group.

He will invite the candidate and his lady to attend their dinners and events. And he will take care to see him through the required degrees to be eligible for the Unit. He has one year to do this. He will retrieve the lucky "Squire's Coin" only if the candidate fails to take the time to qualify for membership. Now you have 80 Knights with the second 40 repeating the actions that attracted him to the Unit. The lucky "Squire's Coin" has an engraved legend that makes one uneasy of lost. Concentrating on getting just one member over a period of 12 months makes Lodge attendance necessary.

This exclusive Unit is identified by a special cap with Bonnet Badge (replacing the familiar black cap) and other regalia.

Remember: Membership is limited to 32nd degree Masons only, and those interested should contact other Brothers in your Valley to begin the process.

The unit is restricted to 32nd Degree Masons only and all other members, regardless of their titles and rank or hat colors, CANNOT hold the honor of membership in this majestic group without first being selected and approved by the members. And then, ONLY as an Associate Member.

Those of the Clan who are awarded the decoration of K.C.C.H., will become an associate member. A red feather will replace the white one on his bonnet, when he wears his Glengarry at the Clan meetings. This is to encourage members to reach for the honors. those who raise to the 33rd Degree will be distinguished with a red, gold and white feather in their bonnet. But the major voting membership will be restricted to 32nd degree Freemasons.

Special Attire Distinguishes this Elite Group

Carefully researched for authenticity, the 17th Century bonnet, with its 3 cock feathers protruding from its Bonnet Badge, will replace the conventional 32nd degree black hat.

A Plaid selected to represent your local Valley will be worn diagonal on a cummerbund. Some Valleys may consider the wearing of kilts, but this is an expensive attire. Thus, we suggest one that is just as elegant and far less costly. An Officer's dinner jacket worn with tuxedo pants and a tux shirt and bow tie for formal attire. Regular wear would be a coat, open collared shirt and bonnet. The logo for the Knights of St. Andrew was researched by Ill. Joe Witzerman, 33°, and has been adopted as the official logo for the Order. The Official Bonnet Badges for regular members and Officers; as well as other accessories have been deeply researched for authenticity and are ready for distribution.

Supreme Queen of Daughters of the Nile Visits Shreveport

Hulene *Mickey* Fitzpatrick, Supreme Queen Daughters of the Nile, was honored at at banquet hosted by Khlra Temple #121 in Shreveport late January. Khlar Queen Robin LaBorde, wife of Robert LaBorde, 32° KCCH and current Chief Rabban of El Karubah Shrine Temple, was hostess to 70 distinquished guests and visitors. Queen Fitzpatrick spoke of the organizations support of the 22 Shrine Hospitals by their 48,000 members. She toured the Shreveport Shrine Hospital the following day. During her reign, she will have visited all of the facilities in North America.

Daughters of the Nile is a benevolent international organization for women who are related by birth or marriage to a Shriner/Master Mason or Daughter of the Nile. It boasts 150 organizations throughout the United States and Canada. This organization was founded in 1913 by 22 progressive women with strength of purpose and vision. Since that time the membership has flourished.

Each year, through their Supreme Convalescent Endowment Fund and Convalescent Relief Fund, Daughters of the Nile contribute well over a million and a half dollars to the hospitals for prostheses, orthotics, braces, shoes, etc. for the children. In addition, many sew garments, quilts, provide toys, hold parties for the children, as well as log many volunteer hours in the hospitals.

REFLECTIONS ON THE DEGREE OF PERFECT MASTER



If you have integrity, nothing else matters. If you don't have integrity, nothing else matters.—Alan Simpson

In MORALS AND DOGMA our Brother Albert Pike exhorts us to be honest in all things. He writes, "The duty of a Mason as an honest man is plain and easy. It requires of us honesty in contracts, sincerity in affirming, simplicity in bargaining, and faithfulness in performing. Lie not at all, neither in a little thing nor in a great, neither in the substance nor in the circumstance, neither in word nor deed....A Perfect Master must avoid that which deceives, equally with that which is false."

The idea of honesty with other humans, and more especially with our Masonic Brothers, is a cornerstone of our order and all good Freemasons practice the concept. To lie to, cheat, or deceive another Mason is simply unthinkable to most of us who have traveled toward the East.

It occurs to me, however, that there is an area of the concept of honesty to which Brother Pike only vaguely alludes; that is, being honest with one's self. The beginning of all true honesty and integrity is when we are honest with ourselves. It is extremely difficult to pass the "mirror test"....that is, looking in the mirror and being truthful to person you see there.

Reflections on the Degree of Perfect Master

Readers of Dostoyevsky will recognize this concept in his characters. The man who lies to himself often soon begins to believe those lies. He then lies to others. If he does so often enough he finds himself unable to recognize integrity in others. And he knows that he cannot trust himself. The man, who cannot trust anyone, or himself, cannot have respect for the same. When respect is gone, love is gone. The man who cannot love yields to his animal impulses and passions and seeks only to satisfy them. The downfall begins the moment he lies to himself.

A Freemason must either decline or improve. He cannot remain inert. In fact, one of the stated reasons that each of us gives for becoming a Freemason is a desire to improve ourselves in the craft.

Self-honesty requires courage. It is risky to level with yourself because you may find that your image of yourself is far different from what you currently hold it to be. But, leveling with yourself is the first step in the quest toward truly improving yourself. And, it is the birthplace of integrity

Spencer Johnson has said, "Integrity is telling myself the truth. And honesty is telling the truth to other people." When we are honest with ourselves, and are thereby honest with others we have power. Power to change and improve ourselves. Power to help others change and improve themselves. Power to effect change in the society in which we live. Power to give to the world. Power to give to life all that we have to give and to take all of the true gifts that life has to give us.

One of the most powerful leaders of our time, Nelson Mandela, put it this way: "As I have said, the first thing is to be honest with yourself. You can never have an impact on society if you have not changed yourself. Great peacemakers are all people of integrity, of honesty, but humility."



REFLECTIONS ON THE DEGREE OF INTIMATE SECRETARY

I know that most men, including those at ease with problems of the greatest complexity, can seldom accept even the simplest and most obvious truth if it be such as would oblige them to admit the falsity of conclusions which they have delighted in explaining to colleagues, which they have proudly taught to others, and which they have woven, thread by thread, into the fabric of their lives. Leo Tolstoy

"You are especially taught in this Degree to be zealous and faithful; to be disinterested..." So begins Brother Pike in his commentary on the Degree of Intimate Secretary. Interesting word, "disinterest," for many take it to mean a lack of interest or concern. Pike uses the word to correctly indicate objectivity combined with a lack of prejudice.

In a lodge of Freemasons there are two subjects that we refrain from discussing. One is politics. Freemasons come from many political persuasions, and some few are apolitical, although I don't think that I have ever met one. We may strongly disagree with one another in everyday life situations. The economy, Iraq, social issues that have become political issues, candidates, and platforms all provide an arena for disagreement and sometimes contention among men of good will. Yet these men, prepared, initiated, passed, and raised can assemble in open lodge and find themselves together in peace and harmony.

Brother Pike, it seems to me, challenges us as Freemasons to carry this disinterestedness beyond the confines of the lodge. Nowhere does he, nor do I, suggest that we must accept the political ideologies of everyone. However, if everyone has value then his or her ideas should certainly be considered. In giving consideration to ideas and philosophies that are contrary to his own, in listening to that which is new, the Mason may often reinforce his own philosophical positions. He will certainly learn something about those who hold to conflicting ideas. He may also, either partially or completely, change his mind. Either way, he will certainly grow as a man and a Mason.

The ancient and accepted Scottish Rite of Freemasonry Valley of New Orleans, Lecture Curriculum has been undertaken by Br. Marc H. Conrad. Br. Conrad has been appointed Director of the Esoteric and Philosophical Lecture Committee.

In keeping with that lofty appointment, Br. Conrad spoke eloquently on January 5, 2005, and presented "an explanation concerning the number of Scottish Rite degrees: 32° and The Past Wisdom." The lecture was well attended and provided much provocation of thought in regard to the origins of the Scottish Rite and the role within the organization of a Scottish Jacobite by the name of Andrew Michael Ramsay. Br. Conrad advised that Masonry first began in the United States in South Carolina in Shepard's Tavern in 1736. Our Scottish Rite appeared in its infancy at the same tavern in 1783 in the form of the sublime Lodge of Perfection. The ancient and accepted Scottish Rite eventually followed and evolved under the leadership of prominent American Masonic luminaries. Our esteemed brother, the Illustrious Albert Pike, birthed the Scottish Rite degrees as they now appear. Br. Conrad further explained that Ill. Br. Pike organized the degrees and described them in a number of publications the foremost being his

Morals and Dogma, which originated in New Orleans with publication in Washington, D.C.

Br. Conrad felt certain that Ill. Br. Pike would urge each of us to walk our "own path to Light and seek out wisdom."

SPRING REUNION





Spring into Reunion

By now the Valleys have scheduled their respective spring reunions. The Reunion Committees have been active contacting Degree Masters and scheduling rehearsals. The Class, Stage, Wardrobe, Sound, Registration and Refreshment Committees have coordinated their respective duties with each other.

By estimation, 100+ Scottish Rite Masons are ready to participate by either working in one of the aforementioned committees or performing on stage in the Degree. That is probably a very conservative estimate. It is the 11th hour and with the stage set, all is well.

The Candidates arrive at the appointed time and are greeted by the Class Committee Chairman. Pictures are taken and the first of many Degrees begin very shortly. Degree cast members rush to wardrobe and review their scripts or at least find their cue cards. The house lights dim, stage lights brighten and the curtain rises for the first of many times. All is well.

I remember hearing about Scottish Rite reunions at a young age. It was a major calendar event for my father. He would have left the house on a Saturday morning long before I awoke and return late that evening. He dressed in a white jump suit with a badge or identification tag hanging from his pocket, wearing an odd looking cap. The early departure repeated on Sunday and again the following weekend, twice a year. I remember him talking to my mother about the large number of people that were in attendance, guests and members that he hadn't seen since the previous gathering and the number in the class. Dad's attendance was important to him as it remains today.

My first real exposure to Scottish Rite Masonry was during the reunion in Marksville. The five Valleys managed somehow to coordinate 5 individual Wardrobe, Stage, Prop, Degree Teams and support together to perform the Degrees in a seamless manner. I can't recall the number of men that attended, but the auditorium at Marksville High School was almost standing room only. Not only was it impressive, but the fellowship and brotherhood observed from members representing the entire state was something to behold. The Shrine held a Ceremonial following the 32° Degree. It was a memorable day for all of us. After having worked in many reunions in Shreveport and understanding all that is involved, the sheer magnitude of what was accomplished in Marksville by the Valleys continues to impress me.

A reunion, much like a family reunion, should bring members, *our family*, together that may haven't seen each other since the previous gathering. We call the semiannual conferring of the Degrees a Reunion but it is much more than exposing new members to the secrets of our Rite. It should also be a renewed time of fellowship and friendship. Instead many report 30 minutes before their Degree, get dressed, recite their part, redress and leave, never once meeting the candidates nor taking the time to enjoy being among the brethren. Others are so busy with lights, props, sound, backdrops and wardrobe that little time is left to socializing. Troubling still is having an unexpected vacancy in the cast, stage, sound, kitchen and

How great it would be to see those seats filled by our members returning to their reunion. The question of the day seems to be How many candidates do we have? More importantly isn't the question to ask is How many of our members have returned? If you didn't work on a Committee or as a cast member, would you attend your reunion? If you aren't involved in such a manner, are you attending your reunion? If not, why not? The stage, costumes, props and scripts are the same or improved. The Degrees are still as beautiful to see and their meanings as worthy to discover.

Are the new members left with the impression that their attendance at future reunions is not necessary or that they are somehow excluded; their destination has been reached and the journey is over? Or are we learning about their talents to include them in our Rite, our meetings, our committees and in the next reunion? Are we holding on to our scripts in the Degrees until death do us part? Or are we approaching the new members during the reunion to see if any would like to be alternates or become a member of the cast?

My experience in Blue Lodge has shown that if the newly raised Master Masons are put to work, given work, shown they are needed in the success of the Lodge, they return on a regular basis. They bring new ideas, new energy and ask questions to gain understanding. Everyone needs to be validated and have a feeling of being a part of the group. The Foundation's philanthropy grew from Scottish Rite Masons. Scottish Rite Masons coming together for a greater cause. Shouldn't our reunions bring those same brethren together for our common cause of mankind's moral, spiritual and intellectual development? Let us get to the point that all really is well. If you haven't attended lately, please consider doing so this year. Your presence is needed by those working behind the scenes as well as by those you need to meet for the first time. If you attend regularly, thank you for your faithful service.

After returning from the January Leadership Conference in New Orleans, I realized there is work to be done to increase the number in attendance during our regular meetings as well as our reunions. The Level 1 session revealed, to me at least, that the new Venerable Masters are charged with conducting the activities in their Valleys and their success will be determined by the programs introduced during their year. The Venerable Master has a great responsibility and therefore our duty is to support him. It takes our members, and can begin with returning to the reunion. See you there.

Reflections on the Degree of Intimate Secretary

The other forbidden subject is religion. As members of our sublime fraternity, we profess faith in a Supreme Being. In our various religious traditions we enhance our faith with commitment to other beings, concepts, and truths that often bring contention when these commitments confront one another, and conflict can often be the result.

However, we are taught as Freemasons, and more especially as Scottish Rite Freemasons, to be tolerant of the faith and traditions of all humans. As with political ideas, the Freemason can learn and grow not only by listening to the religious thoughts and concepts of others but also by giving these thoughts and concepts credence. Through careful thought and consideration the Freemason may also reinforce his commitment to and growth in his own belief system.

The Freemason should be tolerant. Our Brother Rudyard Kipling gives us our example in his autobiography, *SOMETHING OF MYSELF:*

"In '85 I was made a Freemason by dispensation (Lodge Hope and Perseverance 782 E.C.), being under age, because the Lodge hoped for a good Secretary. They did not get him, but I helped, and got the Father to advise, in decorating the bare walls of the Masonic Hall with hangings after the prescription of Solomon's Temple. Here I met Moslems, Hindus, Sikhs, members of the Arya and Brahmo Samaj, and a Jew Tyler, who was priest and butcher to his little community in the city. So yet another world opened to me which I needed."

Our Brother Johann Wolfgang von Goethe cautions us about what we must not become. "People have a peculiar pleasure in making converts, that is, in causing others to enjoy what they enjoy, thus finding their own likeness represented and reflected back to them."

Our task is to hear others and convince them by our example, not to coerce them with our words

How effective we Freemasons would be in this world if we truly lived by the tenets of our sublime fraternity and made our generous and gracious actions and treatment of our fellow humans our messages to our world.

Article VI, Sec. 34 "A two-thirds vote of the Members present shall be necessary to elect a Sovereign Grand Commander; a majority shall be sufficient in all other cases, except when otherwise provided in these statutes".

Article VI, Sec. 35 "No vote by proxy or letter for the election of any officer shall be received or counted".


